Pursuant to Section 551.127 of the Texas Government Code, and in conjunction with the guidance provided by the Governor of Texas in the declaration of disaster and subsequent executive orders altering certain Texas Open Meetings Act requirements, notice is hereby given of a Regular Meeting of the Floresville Electric Light and Power System Board of Trustees to be held at 8:30 a.m. on Wednesday, August 26, 2020, by telephone conference in order to advance the public health goal of limiting face-to-face meetings to slow the spread of the Coronavirus (COVID-19), and for the purpose of considering the items below.
