Pursuant to Section 551.127 of the Texas Government Code, and in conjunction with the guidance provided by the Governor of Texas in the declaration of disaster and subsequent executive orders altering certain Texas Open Meetings Act requirements, notice is hereby given of a Regular Meeting of the Floresville Electric Light and Power System Board of Trustees to be held at 8:30 a.m. on Wednesday, March 31, 2021, by telephone conference in order to advance the public health goal of limiting face-to-face meetings to slow the spread of the Coronavirus (COVID-19), and for the purpose of considering the items below.

Pursuant to Section 30.07, Penal Code (Trespass by License Holder with an openly carried handgun), a person licensed under Subchapter H, Chapter 411, Government Code (Handgun Licensing Law), may not enter this property with a handgun that is carried openly.
