#### Job Summary

The Safety Officer is responsible for acting as the front-line safety professional conducting safety inspections, observations, investigations, safety training, and regulatory compliance for OSHA, DOT, and EPA. The Safety Officer anticipates and predicts hazards based on experience, historical data, and other informational sources. He/she identifies and recognizes hazards in existing work practices and on planned or in-progress construction or maintenance activities. Responsibilities include oversight of the field staff, internal office staff and building facilities staff work procedures. The Safety Officer evaluates and assesses the probability and severity of loss events and accidents which may result from actual or potential hazards. The Officer applies methods of conducting hazard analyses and interprets the results. The Safety Officer provides advice and counseling about compliance with safety, health and environmental laws, codes, regulations, standards, and the related company requirements.

### **Essential Functions**

The Safety Officer provides advice, counseling and training on regulatory compliance with safety, health and environmental laws, codes, regulations, standards, and the related Company requirements. Inspects workplace facilities, including tools, equipment, and machinery, to identify and correct deficiencies or potential hazards, and to ensure compliance to OSHA / DOT / FELPS safety programs and regulatory requirements. Assists management and leads the investigation of safety-related damage incidents, employee injuries or occupational illnesses, and motor vehicle accidents to determine cause and contributing factors, overseeing and managing all Worker's Compensation Claims. Develops mitigation measures and corrective actions for the objective

findings of observation and inspection deficiencies, incident investigations, and like-industry experience to reduce the risk of hazards from recurring within the organization. Leads the FELPS safety committee. Administers training, safety recordkeeping, and documentation for compliance to safety training policies and FMCSA DOT requirements. Recommends safe work processes and demonstrate personal protective equipment safety features that will reduce employees' exposure to workplace and environmental hazards. Ensures tools, equipment, materials, vehicles, and technical instruments are fit-for-purpose, functional, calibrated, and the appropriate protective equipment, methods, guard, management systems are in place to reduce or eliminate the risk of employee injuries or illnesses. Performs other duties as required and/or assigned.

#### Minimum Qualifications

- An associate degree, or equivalent related work experience of 4 years.
- Experience as a safety professional
- Knowledge of overhead and underground distribution safe work practices with reference to OSHA standards.
- Experience as a Lead Lineman, Foreman or other supervisory role is desirable.
- Knowledge in accident investigation following root cause analysis principles.
- Knowledge of laws, legal codes, formal interpretations, precedents, government regulations, executive orders, agency rules, and procedures.
- Knowledge of state and local DOT requirements.
- Knowledge of business and management principles and practices involved in strategic planning, resource allocation, human resources modeling, leadership technique, production methods, and coordination of people and resources.
- Knowledge of principles and processes for providing customer and personal services. This
  includes customer needs assessment, meeting quality standards for services, and
  evaluation of customer satisfaction.
- Ability to consider the relative costs, risks, and benefits of potential actions to choose the most appropriate one based on business and employee needs.
- Ability to actively listen, giving full attention to what other people are saying, taking time to understand the points being made, asking questions as appropriate, and not interrupting at inappropriate times.
- Ability to use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions, or approaches to problems.
- Ability to bring separate parties together to attempt to reconcile differences and negotiate results.
- Ability to identify complex problems and review related information to develop and evaluate options and implement appropriate solutions.
- Ability to monitor/assess performance of self, other individuals, or organizations to make improvements or take corrective actions.
- Good written and verbal communication skills.
- Clarity of vision at 20 feet or more and 20 inches or less, with the ability to judge distance and space relationships.
